Sir, we write this as an organisation representing the members of the Akali Tange Association whose members are the victims and the rightful custodians of the victims of the Giant Porgera Gold Mine.

As you are aware, Akali Tange Association Inc (ATA) has submitted 256 names of victims who have been shot death, injured and raped by the Barrick PJV Security Personnel and its allies on the 04th September, 2015 as per the United Nations Business and Human Rights Guiding Principles to seek remedy under the PJV's Grievance Mechanism. We received an acknowledgement of receipt of the claims and a number 3936.

However; to date there has never been any response from Barrick and this has caused frustration and anger among the victims and the custodians of the victims. Therefore, to ease the tension, frustration and the anger of ATA's members, ATA is now proposing to stage a peaceful protest to petition your subsidiary Barrick Niugini Limited (BNL) by giving the BNL 14 Days ultimatum to respond to ATA's demands for compensation and remedy.

Further, the protest march will start from ATA's head office at Lower Yanzkona, Porgera Station and will proceed to the PJV Mine Site Yoko I Office to present the petition. Thus, ATA would like to notify your office of its intentions and would cordially like to invite you and your management team to attend and receive ATA's petition on the date and time scheduled below.

Moreover, ATA has invited all media personnel in PNG and aboard and ATA as a Human Rights Advocate will stage this protest march as a very peaceful one.

Therefore, we are notifying your office in advance of the nature of the peaceful protest and the locations as well as the date and time the peaceful protest will be staged.

The date and time of the peaceful protest will be as follows:


