Directing upon the respondents to immediately develop a time bound action plan to comply with the recommendations of the 7 Member Committee of the Task Force (as of Annexure E) and also for widening Kamardoho to Kachuati canal and expanding the Golakata Bridge to allow Boral to flow through Charghat to Hurasagor.

Let a Rule Nisi be issued calling upon the Respondents to show cause as to why they shall not be directed to restore and protect the Boral river (Annexures- A, A-1 and B respectively) by demarcating the same as per the CS Map and /or current flow protecting the same from contrary uses like leasing out for commercial fisheries and otherwise, removing / altering all harmful structures obstructing the river as mentioned in Paragraphs no. 13, 14, 19 and 21 of the writ petition and reconnecting the river with its source, contributory water bodies and branches as mentioned in Paragraphs 7 and 9 of the writ petition and also why they shall not be directed to ensure the required environmental flow of the said river and/or pass such other or further order or orders as to this Court may seem fit and proper.

The Rule is made returnable within 04(four) weeks from date.

Pending hearing of the Rule, the respondents are hereby directed to submit a time bound action plan to comply with the recommendations of the 7 Member Committee of the Task Force (Annexure- E) for widening the Kamardoho to Kachuati canal and thereby expanding the Golakata bridge to allow the Boral river to flow through Charghat to Hurasagor and submit the report thereof before this Court within 06(six) weeks from date.

Let the notice of this Rule be served upon the respondents in usual course and also by registered post immediately on two sets of requisites being put in within 72 hours.
